PURPOSE AND TASKS OF THE ACADEMIC DISCIPLINE

The purpose of teaching the discipline Obstetrics and gynecology nursing. Reproductive health and family planning in the 3th year is to master the principles of pregnancy, childbirth and the postpartum period, mastering the basic principles of diagnosis, treatment and prevention of female reproductive system, use of basic and additional research methods, demonstration of skills and abilities according to the educational and qualification program.

The main tasks of studying the discipline Obstetrics and gynecology nursing. Reproductive health and family planning in the 3th year are to

- Interpret the clinical anatomy and physiology of the female genitalia.
- Plan the features of physiological pregnancy, physiological childbirth, the postpartum period
 - Plan the management of women with diseases of the female reproductive system.
 - Perform the necessary medical manipulations.
