DESCRIPTION OF THE EDUCATIONAL COMPONENT. The educational component (EC) "International Humanitarian Law" is formed on the basis of one of the most complex, emotionally sensitive, dilemmatic in understanding and applying branches of international law, which regulates wars, which are always accompanied by violence, cruelty and aggression. Interest and demand for international humanitarian law arise only when the horrors of war occur. International humanitarian law is a part of international law aimed at limiting the use of violence during war, the use of means and methods of war, and the protection of war victims. The states parties to the Geneva Conventions for the Protection of War Victims have undertaken to comply with them under any circumstances and to disseminate knowledge about the content of the norms of international humanitarian law. Knowledge of international humanitarian law as a result of its development and the participation of states in the Geneva Conventions for the Protection of War Victims, the dynamics of armed conflicts in the world are becoming an integral part of any education in the 21st century. The armed conflict caused by the aggression of the Russian Federation against Ukraine highlights the need for this knowledge for Ukrainian society in general and students in particular.

OBJECTIVE : consists in the formation of certain competencies in second-level master's degree students studying in the specialty II "Dentistry" on the basic provisions of international humanitarian law, studying its essence and features, principles and sources, subjects for further active activity in ensuring human rights in the field of health care during war and hostilities, as well as to increase the legal awareness of health care professionals by obtaining the necessary amount of theoretical legal knowledge and practical skills on the features of the operation of the norms of international humanitarian law relating to human rights in conditions of armed conflict, on the implementation of the norms of international humanitarian law and responsibility for their violation, familiarization with the system of the International Red Cross and Red Crescent Movement.

LEARNING OUTCOMES: acquiring knowledge about the nature and content of international humanitarian law, understanding the inextricable link between international humanitarian law and the principles of humanity and humanism, and the values of modern civilization; getting acquainted with the activities of international humanitarian organizations that provide assistance during armed conflict; informing about the mechanisms of responsibility of the Russian Federation for aggression and serious violations of international humanitarian law, individual criminal responsibility for war and other international crimes; forming a personal attitude towards such values as human life, peace, security, humanity, humanitarian act, mutual assistance; ability to apply the provisions of national legislation,

international treaties with the participation of Ukraine and characterize national legislation from the point of view of its compliance with international humanitarian law.

EVALUATION

Current educational activity (PND). Assessment of the success of education seekers is carried out in accordance with the Instructions for assessing the educational activity of higher education seekers at KhNMU (<https://knmu.edu.ua/documents/normatyvni-dokumenty-navchalnogo-proczesu/>). The assessment for a practical or final lesson is from 2 to 5 points. Submitting assignments late for unwarranted reasons entails a reduction in the grade in accordance with the percentage of delay in time from the time of completing the assignment. Assignments are checked within 24 hours. Grades are posted in the electronic journal. Unsatisfactory grades are worked out in accordance with the Regulations on the procedure for working out academic classes by students of KNMU (https://knmu.edu.ua/wp-content/uploads/2021/05/polog_vidprac_zaniat.pdf).

Final semester test is carried out after the completion of the study educational component . **The form of control** is “ credit ”. Points for educational components are calculated as the arithmetic average of the points of the current control for all topics during the entire period of studying the educational component (with an accuracy of one hundredth) according to the table “Conversion of the average score for the current control into a multi-point scale (for disciplines that end with a credit)”, which is added automatically within the functionality of the electronic journal of the ACS. Total educational activity is determined in points from 120 to 200 and a mark - “credited” or “not credited”.

Appealing the results of the final control is carried out in accordance with the procedure established at the KhNMU (https://knmu.edu.ua/wp-content/uploads/2021/05/polog_apel_kontrol.pdf).
